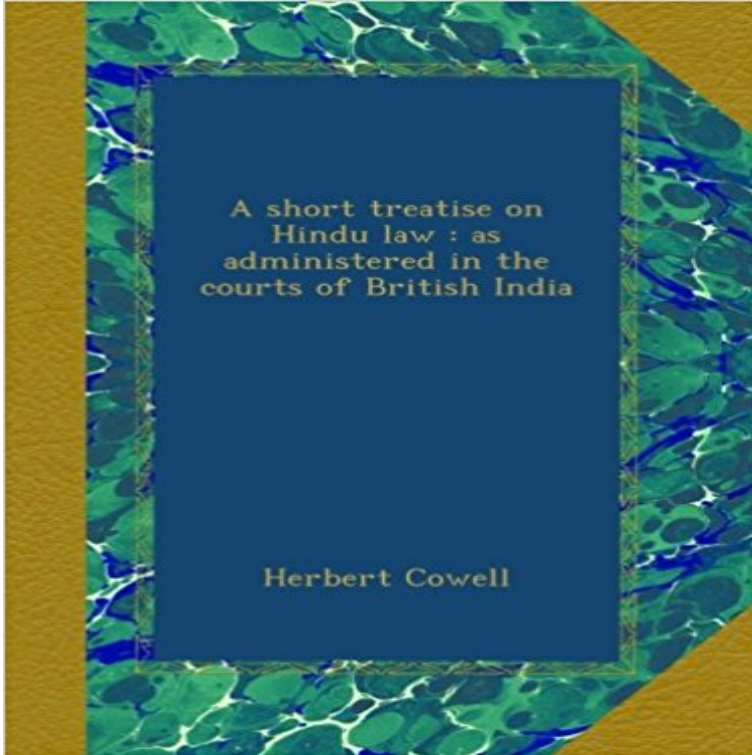


A short treatise on Hindu law : as administered in the courts of British India
