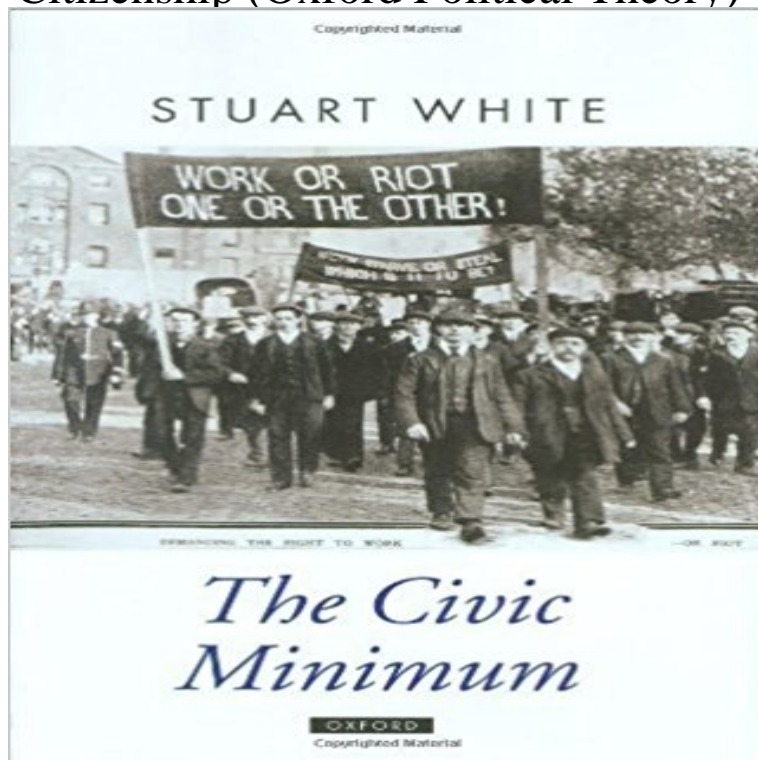


The Civic Minimum: On the Rights and Obligations of Economic Citizenship (Oxford Political Theory)
