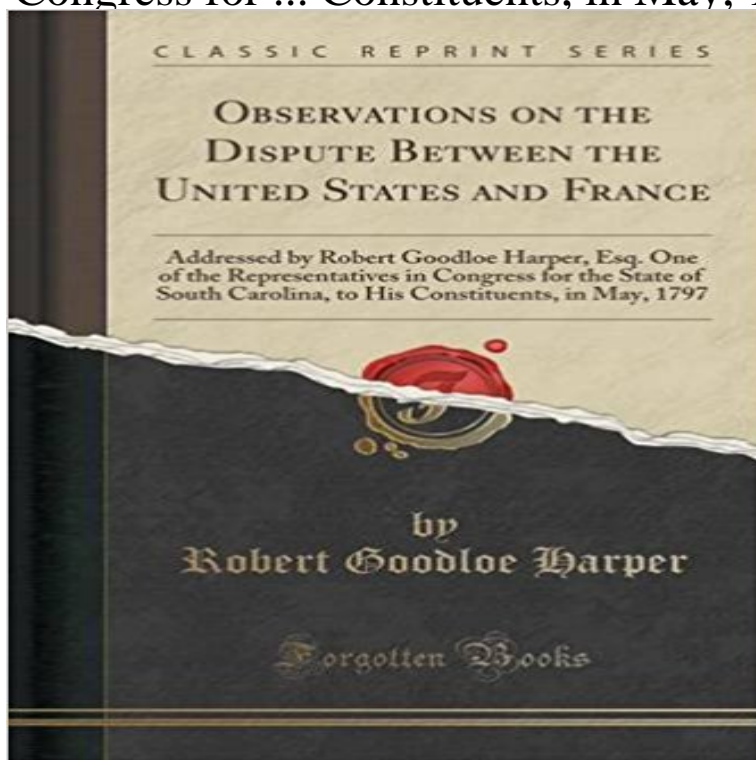

That State having suffered more than the other parts of the American Union, by the operations of the contending armies during the latter period of the American war, it was natural that Mr. Harper, in common with his fellow-citizens of South Carolina, should retain much of the animosity against Great Britain, which that contest had excited. In addition to this general sentiment, the rules which this country had laid down, at the beginning of the present war, respecting the commerce of France and her colonies, although strictly conformable to the law and practice of nations, and to the conduct observed in all former wars, had been greatly misrepresented by the activity of the partisans of the French in America.
